- 1. Updates per Nordique: Richard shared updates from Nordiqu Canada:
 - a. Age Category names will be changed to be consistent across Canada to move away from Atom/Midget etc to U [age] category naming ie. U13
 - b. There was a proposal to change Easterns to Dec however this was strongly opposed by all provinces and has gone back to Nordique Canada for re-evaluation
 - c. High Flouro regulations for tier Races: Provinces requesting confirmation that high flouros will not be used for any races so that suppliers can be notified and not order wax for the fall season.
- 2. Season Debrief: (PASTE in Feedback File from Megan):

SUCCESSES:

- a. Megan: Mentorship that happened this year re: coaching and waxing
- b. Steven: Hardware received at Can Games.
- c. Megan: Club Representation at races: club clothing and pride still being seen at provincial races in combination with provincial clothing. This was echoed by Ihor emphasizing the quality that is coming out of all clubs this year.
- d. Pauline: Per capita Manitoba skiers ranked very well this seasons when percentages were compared to past years as well as other provinces. Megan shared that this is a reflection of strong CLUB coaching not just strong Provincial coaching as was the case in past decades.
- e. Pauline: Pleased that the Can Games qualifier was able to be completed with such success.
- f. Pauline: Can Games spirit especially show in the female squad with the "inspiration wall" at the games as an example.
- g. Jackie: Shared that the communication re: season plans and team races was very well stream lined this season and the season was well planned out and communicated.

CWG SELECTION Process Discussion points:

- a. Criteria could have been explained better: some athletes thought it was souly placing. Current guidelines should be made clearer with this detail.
- b. U20 overall category but not by year of birth: criteria did not reflect this.
- c. Provincials 2018 distances were set based on what was anticipated as a selection race for CWGs.
- d. Mathematical Formula: Needs to be fully transparent so that anyone reading this can do the same math and know objectively the outcome.

- e. How to account for skiers competing out of province in deeper competitive fields: 11% was chosen as a factor based on the result spread analysis (85% at EASTERNS is not 85% at CCSAM Provincials so 11% bonus was added based on the race results posted the previous season ie. Eastern's racers were 11% faster that year).
- f. The suggestion to offer "Prequalification" was not accepted by this committee for several reasons:
 - a. This is not the international standard: All sports still have qualifiers and this provides athletes experience with under pressure performance.
 - b. It ensures there are a maximum number of athletes to race in a qualifier so there is less chance for someone to race against themselves in a category.
- g. Qualification Guidelines: 30/70 split for race results was reported to be fair (ie some from previous and current season). Other's wanted the split to be 20/80 so that current season performance is more strongly represented. The Committee TODAY: 20/80 might be too high with more emphasis on the qualifier. 30/70 was favored. % ages better defined, and a plan for ties. Jackie requested increased transparency re: the formulas being used and then examples provided in the document based on real past results. Steve requested examples of what a %age behind the winner be equated to #of seconds. Also add examples of what 20/80 compared to 30/70. Steve advocated that if athletes have a tangible # to help set goals and targets that this would be helpful (ie. I need to be 5 seconds faster to achieve 80% behind the winner).
- h. What to do with DNFs and Ties (in the event of a tie there are guidelines re: other criteria to go to). Does the current system reward consistency? Does the current system recognize single race results that are out of character?
- i. Lorne liked that the qualifier was an Interval start for fairness to the athletes.

NATIONALS:

CANCELLATIONS:

- a. What to do when an athlete drops out of a team trip?
 - i. Clear language is required to outline expectations and consequences of withdrawing from a position on the team.
 - ii. Require a deposit when spot is accepted
 - iii. Plan for when there are not the full number of athletes who applied (CCSAM to cover the cost? Send out a second call for athletes and shift focus to 'athlete development.')
 - iv. Cancellation due to illness/injury/unforeseen: need guidelines for this and have athlete 'sign off' indicating they understand.
 - v. Megan encouraged the group to reflect on where we are as a PDP team: developmental, high performing, other? To help guide decision making on team selection guidelines.

ACTION: Ihor and Jackie to provide language around cancellations.

ACTION: Letter to all PDP athletes explaining the events that occurred and rationale and what changes have been made to mitigate this regarding Nationals (WHO will draft?).

MIDGETS at Nationals:

Normally there is no midget category. No further discussion.

AWARD NOMINATIONS:

ACTION: Decision to have this open all season to encourage nominations at the time that great things happen.

- 3. PDP Committee next year: TOR updated in 2017
 - a. Megan declared she will resign from being the chair of PDP Megan expressed the difficulty of being chair and a coach which complicates sharing of opinions and/or being objective. Megan willing to stay as Red River Coach Rep. Suggestions:
 - Pauline stepped down as Co-Chair: Pauline would like to remain on the committee.
 Pauline has agreed to continue as Team Manager.
 - c. Karin suggested that the new committee be formed and that the committee members determine who the Chair is.
 - d. Jackie requested clarification re: PDP roles (Chair, Manager, Parent Rep, Athlete Rep)

ACTION: Megan and Jackie will review the TOR and enhance by defining the roles. Clarify the representation on this committee (Club Reps, Para Rep, etc). Pauline suggested consideration of including a "technical" rep (Wax Tech) to help respond to these issues as they arise in PDP. Karin to also update the wording re: Chair. Include "Team Manager" as a role in the TOR and define this role. Jackie to request Pauline to send a 'job description' to Jackie/Megan.

ACTION: Send this updated list of positions in TOR with role descriptions to PDP with invitation to express interest in the open positions (Parent Rep, female Athlete Rep). Coach Reps required to be connected to PDP athletes.

Ihor suggested the committee consider dedicating 1 position to: ski technique lead, however discussion lead to not doing this but to all sharing this responsibility to keep current and share knowledge and skills.

Steve requested a standing item being "professional development" so that we can share and plan for keeping up our knowledge. The committee agreed.

- 4. Planning for next season;
 - May 25th Camp date set for Red River Nordic Spring Camp: Megan and Elise proposing opening this up to other clubs as the CCSAM Spring Camp. This will be held in Riding Mountain. Athletes and Coaches to assist due to the heavy numbers. PDP athletes are

- at least 12 years of age and racing in the Midget category. Betsy Harris will be asked to attend.
- b. Early on-snow camp: Athletes must declare intent to attend Nordic vs Biathlon Nationals. Biathlon athletes may then not be included in the Nordic early on-snow camp. Megan proposed inviting BAM to send athletes and a coach at the same time. We discussed what the intent of the Early camp is? Getting on snow early, practice on elevation (down hills), provides a leg up on the race season for experienced racers, (2017 Top 6 plus 2 discretionary athletes from previous season results &/or CWGs years 5 female/male athletes), goal is to take athletes who have travelled the previous season.

The committee agreed that athletes should not have to declare Nordic/biathlon, and that there is no negative to supporting Nordic athletes who become biathaletes; this is still a win for Manitoba athletes.

ACTION: The committee agreed to hold an early on-snow camp at Sovereign which is the site for Nationals 2010, the athletes must be athletes who have travelled (qualified) for previous PDP team trips, It is the boards intent to pursue a PDP early on snow camp as well as a late Nov/Early Dec camp regardless on snow conditions.

Discussion re: Collaboration Potentials: Saskatchewan Collaboration? Biathlon collaboration? Sask/Man Provincials.>> ACTION: Reach out to Sask re: Fall Camp collaboration with Saskatchewan. KNBC expressed interest in hosting 2020 Provincial Championships.

- Sucesses:
 - Manitobans continue to perform well at National races. Sign of good club coaching programs.

- CWG:
 - Reviewed the athlete survey distributed post Games and discussed each response
 - Improvements to CWG Selection Policy

- 1) Thanks for weighing in on the PDP events and date selection for Canada Games selection races. I heard from Tamara, Casey, Lucas, Lorne, Ihor and Steven. Hello committee.

Next season we have a few definite trips: Canada Games and Nationals. Although note tight turn around time in between the 2 events - only 10 days.

We have a necessary race to schedule: Canada Games Selection races (2 races, 1 classic and 1 skate). Biathlon Manitoba has already put forward their selection race date so we also need to get a date out there.

We have a highly likely event: Easterns Feb 1-3 (Likely to be targeted for Canada Games team, but to be discussed in September)

If we were to call this a Canada Games prep event then we would hope to have Games support staff on this trip as well. To be discussed.

We likely need another option for PDP team trip. This might be the trip to bring the larger team for gaining experience. Options are:

- O Cup in thunder Bay Jan 4-6
- Westerns in Kelowna Feb 8-10
- Alberta Cup in Canmore Jan 19-20

I have listed the events below, so you can see the calendar as a whole and also some notes on things like a rationale for choosing the event, or some advantages and disadvantages that Pauline and I thought of for each. Please consider the information.

The decisions we need to reach are: 1) what date will be our Canada Games selection races 2) Is committee happy with decision to send team to Easterns and not Westerns and 3) what will our other PDP trip be this season?

(For future consideration: Canada Games trials location: obviously snow dependent, but needs to be somewhere with decent grooming and terrain. Could potentially do classic in Kenora and skate in Falcon? Close enough to drive between easily, likely Kenora race first then overnight in Kenora, then Falcon?)

Background info that we need from Karin: what is latest possible date of submission for CWG team?

I have put in **bold** what I would consider "ideal" spacing of team trips.

Dec 1-9 (proposed) Early snow camp: Silver Star; tie in with Dec 8-9 NorAm in Vernon?

(Dec 13-16 World Junior Trials, Whistler. We need to be aware of this because of Conor and Levi N, who may be vying for spots our CWG team)

(Dec 15-16 BAM Canada Games selection races, with their backup date listed as Dec 22-23 however I think that has already caused some friction and Karin

has told them they can't block off both of those weekends because we also need to get a race in there)

committee decision: What do we choose as our first choice for the CWG trial race? Dec 22-23 or Dec 29-30 or ???

Dec 22-23 Possible dates for our Canada Games selection races with back up date of Dec 29-30 advantages: Free up christmas holidays for family and travel; race quality for athletes not affected by holiday schedule - better performance? disadvantage: same as BAM's back up date

Dec 29-30 Possible dates for our Canada Games selection races with backup date as Thunder Bay O Cup

advantage: No conflict with BAM

disadvantage: affected by Christmas holidays; less room for backup date (we need to find out the cut off date for team selection); out of town back up race if we have to use O Cup, and assuming we take a team to O cup

Jan 4-6 possible Ontario Cup Thunder Bay

Rationale: Good quality race experience for our larger team trip next season? Good timing for an early season race especially for those not at the early snow camp

Advantages: Well separated from the Easterns trip; Good timing in race calendar to use as an Easterns / Nationals selection race. Good timing for teachers and students to be able to attend, as not quite back to school yet

Disadvantage: for those at CWG selection race, this is 2 race weekends in a row out of holidays.

Jan 19-20 possible Alberta Cup in Canmore

Advantages: Good quality race experience; Not scheduled in the Christmas break period like the O Cup option

Disadvantages: cost (more travel); less time between this trip and Easterns trip (only 10 days, Easterns departure likely to be Jan 30)

Feb 1-3 <u>Easterns in Collingwood, Ontario</u>

Rationale for choosing Easterns over Westerns

- Easterns and Westerns are too close together to do both (1 week apart);
- Better time frame between Easterns and CWG than Westerns and Canada Games (a 3 week window vs 2 week);
- great quality race (usually huge field)

(Feb 8-10 Westerns Kelowna)

Feb 24-March 3 Canada Games in Red Deer (biathlon is previous week)

March 13-20 Nationals in Ottawa
