Radio equipment has been helpful. Staffing availability is limited so the operating hours may have to be reduced. An accessible toilet is scheduled for December 1. Going to install a high-performance air filter. Need to make these things clear on the website: WPNC requires masking. Doesn't require vaccinations. You can come in and change your boots. Do not linger. Coffee and CB's will be for take-out.
